### Consent

By using our website, you agree to our Privacy Policy and agree to its terms.

## Information We Collect

The personal information you are asked to provide, and the reasons why you are asked to provide it, will be clarified to you at the time we ask you to provide your personal information.

If you contact us directly, we may receive additional information about you, such as your name, email address, phone number, the content of the message and/or attachments you may send us, and any other information you may choose to provide.

When you register for an Account, we may request your contact information, including items such as name, company name, address, email address, and phone number.

## How We Use Your Information

We use the information we collect in a number of ways, including:

- Provide, operate and maintain our website
- Improve, personalize and expand our website
- Understand and analyze how you use our website
- Develop new products, services, features and functionalities
- Communicate with you, either directly or through one of our partners, including for customer service, to provide you with updates and other information related to the Website, and for marketing and promotional purposes.
- Send you emails
- Find and prevent fraud
- Log files

IPECF follows a standard procedure for using log files. These files record visitors when they visit websites. All hosting companies do this and a part of the analysis of hosting services. The information collected by the log files includes Internet Protocol (IP) addresses, browser type, Internet Service Provider (ISP), date and time stamp, referring/exit pages, and possibly the number of clicks. These are not linked to any information that is personally identifiable. The purpose of the information is to analyze trends, administer the site, track the movement of users on the website, and gather demographic information.

## Cookies and web beacons

Like any other website, IPECF uses 'cookies'. These cookies are used to store information, including visitor preferences and the pages of the website that the visitor accessed or visited. The information is used to optimize the user experience by customizing the content of our website based on the type of visitors' browser and/or other information.

## Privacy Policies of Advertising Partners
